CIRCULAR

Sub: <u>Instructions to be observed while submitting a report on alleged illegal construction/health hazard.</u>

After realising practical difficulties being faced by the Directorate of Panchayats and to avoid duplication of work of obtaining report, panchanama, etc. on the second occasion, it is felt necessary to lay down certain guidelines to be followed while conducting panchanama:-

- 1. At the outset it is required to be mentioned that any complaint received in this Directorate may contain allegations of an illegal construction/health hazard, etc. as the case may be. Before approaching the Directorate, such a complainant usually makes attempt to redress his grievance at Panchayat level and later on tries to convince the Block Development Officer.
- In order to deal with issues, it is desirable that the facts/contents are thoroughly examined. It is, therefore, felt necessary that such a job is performed by a team of Officials/persons consisting of E.O. (R.E.); E.O.(V.P); Village Panchayat Secretary and a member of Village Panchayat by making a site inspection after notifying to the Complainant and the Accused (Opponent). (The practice of preparing report, sketch, Panchanama by the Village Panchayat Secretary should, therefore, be discontinued hereafter).
- The aforesaid Officials after identifying the site; address and names of the Complainant/Accused should compare the contents of complaint with the site plan of the alleged illegal construction and thereafter record the proceedings/panchanama indicating therein the specific discription of illegalities noticed; dimensions of the alleged illegal construction and the illegalities explicitly.
- Many a times site in question is not properly identified and wrong survey number is indicated in the complaint. To overcome such issues, it is necessary to obtain cadastral survey plan and Form No. I & XIV from the Complainant/Accused and indicate the illegalities in the cadastral plan before submitting the report to this Directorate. This should be in addition to the sketch drawn by the E.O. (R.E) on a separate sheet of paper.
